According to the Sexual Harassment of Women at the Workplace (Prevention, Prohibition, Redressal) Act, 2013, the Internal Complaints Committee is formed in institutions to prevent the Sexual harassment of Women at the workplace.

Under this act any unwelcome act or move directly or indirectly made to a women such as: physical contact and advances, a demand or request for sexual favors, making sexually coloured remarks, showing pornography, or any unwelcome physical, verbal or non-verbal conduct of sexual nature.
